



Memorandum of Understanding

Between

Belarusian State University of Informatics and Radioelectronics

And

Shakhes Pajouh Research Institute (SPRI)

This agreement is made on March 25th of 2019 between the SPRI, a public institution of higher education which is located in 2nd, Fl. No. 2 Maragheh St. Ostad Nejat-o-llahi St. Vila, Enghelab Ave. Ferdowsi Sqr. Tehran, Iran (hereinafter Shakhes Pajouh Research Institute), which is represented by Chancelor, Dr. Amir Mahmoudzadeh, and Belarusian State University of Informatics and Radioelectronics which is located in vulica Broŭki str. 6, Minsk 220013, Belarus which is represented by Rector, Dr. Vadim Bogush.

In the spirit of friendship and with mutual interest in cooperation, the SPRI and Belarusian State University of Informatics and Radioelectronics came into this Memorandum of Understanding (MOU) to promote joint economic and investment collaboration and agree as follows:

ARTICLE 1: SCOPE OF COLLABORATION

- i. Areas of collaboration may be proposed by either institution and may include, but are not limited to:
 - Joint teaching, research and publication activities;
 - Cultural exchange;
 - Set up branches in Iran;
 - Joint research and training center;
 - Sharing or creation of educational materials and resources;
 - Joint lectures, conferences and seminars;
 - Staff professional development.
- ii. Any specific activity developed under this MOU shall be detailed in a subsequent agreement, signed by each institution's authorized signatory, which will describe the scope of the proposed activity, intended outcomes, budget, and responsible departments or individuals. For The SPRI, the authorized signatory is either the Provost or Dean of the appropriate unit.
- iii. All activities shall be subject to the availability of funds and the approval of each institution's authorized representatives.





ARTICLE 2: DURATION AND EVALUATION

- i. This MOU shall be in effect for a period of Five (5) years from the last date of signature. Either party may request termination of this agreement, in writing, ninety (90) days prior to the proposed termination date. Any activities in progress at the time of termination shall be permitted to conclude as planned unless otherwise agreed in writing.
- ii. A joint evaluation of the MOU will be initiated by the designated representatives six (6) months prior to the expiration date. Following the evaluation, the MOU may be renewed and resigned for an additional five (5) year period.

iii. Amendments to this MOU may be requested, in writing, by either party and approved by the authorized signatories.
